CODE OF CONDUCT

All members at Kraft Sportssenter are obligated to follow and keep themselves updated on our Code of Conduct, Terms of Agreement and other regulations such as for booking and climbing.

- All equipment must be washed/dried off after use. Put all used equipment back to its rightful place and leave the gym clean and tidy. Show consideration to those that work out around you, and do not use more equipment than necessary. Treat the equipment carefully and only use it for its intended use.
- Show consideration when using chalk at the gym. Wash off all chalk-remains from the equipment after use.
- Bags, backpacks, and outerwear should mainly be stored in the wardrobe or in the express-closets close to the
 entrance. Such personal belongings should not be placed that it might interfere with other members movement in
 the gym and other relevant areas. When attending group classes, bags and such are not allowed into the hall. During
 group classes, such belongings should be stored in the wardrobe or in the express closets.
- We recommend the use of towels on equipment in the strength rooms, at the bicycle hall and on the mats at group classes.
- It is not allowed to walk or train barefoot at Kraft, with the exception when using the martial arts room and when exercising yoga in the group halls. Members must use shoes intended for indoor use. Shoes that are used outdoors cannot be used indoors. Outdoor shoes are placed on assigned areas at the entrance or stored in closets in the wardrobes.
- It is mandatory to use clean workout clothes. It is not allowed to work out with a bare torso or only a sports-bra. Shorts etc. should be long enough to cover your entire bottom. Kraft employees have the right to point out inappropriate use of clothing.
- Members are personally responsible for their private belongings and for their safe storage during activities at Kraft.
 When leaving the center, members must empty their closets and take their shoes with them. Kraft is not responsible for belongings left at the center. With the exception of paid closets for permanent storage, closets are emptied at closing and are the belongings are placed at Kraft´s own lost and found. The lost and found is emptied the first Monday of each month.
- Photographing or filming of other members or staff without consent is prohibited. It is not allowed to photograph or film in the wardrobes.
- Members must at all times act respectfully above others at Kraft and follow instructions and remarks from the staff.
 With the exception of arranged activities, it is only employees at Kraft that is allowed to train and instruct members at Kraft.
- Skis, bikes and other similar equipment cannot be stored inside Kraft but be placed outside the building.
- If acting against Kraft's terms of agreement or other agreements such as the Code of Conduct, or safety regulations, Kraft can remove members immediately and expel members from the center up to 1 year or end the agreement with immediate effect without the obligation to refund paid membership fee. With an eventual expelling of a member, the member will be obliged of his/her membership agreement but will not have access to Kraft's facilities.
